### PRODUCT DESCRIPTION

Sika<sup>®</sup> MouldBuster is a powerful, fast acting solution which is effective on most surfaces. It removes algae, mould and green growth without the need for scrubbing or pressure washing.

Sika<sup>®</sup> MouldBuster is approved under the Control of Pesticides Regulation 1986 (as amended) for use as directed. HSE No 8376. Also approved for use in Ireland, PCS No. 96329.

### USES

Treatment for the removal of all types of organic growth from surfaces including:

- Patios
- Driveways
- Fences
- Brickwork and masonry
- Decking and garden furniture
- Roofs
- All exterior hard surfaces

### PRODUCT INFORMATION

<b>Packaging</b>	5L jerry cans
<b>Shelf Life</b>	24 months from date of manufacture in unopened containers and stored in accordance with below.
<b>Storage Conditions</b>	Store upright in original, tightly sealed container, and in a dry, cool and well-ventilated area (between +5°C and 25°C), protect from sunlight and frost.

## APPLICATION INSTRUCTIONS

### APPLICATION

Wearing suitable protective equipment, dilute 1 part of Sika® MouldBuster with 4 parts water in a watering can or a low-pressure sprayer. Apply diluted mix directly onto the affected surface, ensuring entire area is saturated. Leave to dry, keeping pets and children away from treated area during drying period. Sika® MouldBuster works over several weeks to kill and remove mould and algae - results will be seen within days. Any stubborn growths can be removed by lightly brushing away once dead.

### Coverage

The approximate application rate is 4m<sup>2</sup> / litre when diluted as advised and applied with a garden sprayer – dependent on evenness and porosity of the surface.

### LIMITATIONS

- Do not use if rain is expected within 5-6 hours of application.
- May leave a slight sheen on the surface after application. This will dissipate naturally over time.
- Use only as directed.
