S-Felt T-300 is loose laid according to the valid installation instructions for Sarnafil® and Sikaplan®. If necessary, S-Felt T-300 can be tacked to the substrate with Sarnacol® 2170 or Sarnacol® T 660. Adjoining sheets must overlap at least 50 mm.
