## APPLICATION INSTRUCTIONS

#### **APPLICATION**

## **Application Method**

Soak a clean white cloth with Sarna® Seam Cleaner and then clean the seam area or surface of the membrane. The cloths should be changed frequently to maintain clean surfaces. In the seam areas allow Sarna® Seam Cleaner to evaporate sufficiently before hot air welding.

#### **FURTHER DOCUMENTS**

Installation instructions: Relevant roof waterproofing membrane.

#### **LIMITATIONS**

- Dissolves thermoplastics not resistant to solvents (e.g. polystyrene, polycarbonate, acrylics).Do not use the cleaner to wash large areas of roof surface.
- Sarna® Seam Cleaner is not suitable for degreasing or cleaning metal sheets or the cleaning of tools. Sarna® Seam Cleaner cannot be used for cleaning wet or dry adhesive residue from membranes or tools.
- White cloths will effectively absorb dirt and the colour will not stain the membrane.
- Use solvent resistant gloves and eye protection glasses during application.
