## **APPLICATION INSTRUCTIONS**

#### APPLICATION

#### **Application Guidline:**

Based on the valid installation instructions of the relevant roof waterproofing membrane.

Depending on the degree of soiling, the subjected area should be cleaned first with water, brush or cleaning pad. Soak a clean white cloth with Sarnafil® T Clean and then clean the membrane, tool or metal sheet. The cloths should be changed frequently to avoid the spreading of dirt. When cleaning seams a new cloth is to be used. Allow Sarnafil® T Clean to evaporate completely.

In seam areas allow Sarnafil<sup>®</sup> T Clean to evaporate completely before preparing the seams with Sarnafil<sup>®</sup> T Prep.

## LIMITATIONS

- Avoid contact to materials that are not resistant to solvents.
- In seam areas Sarnafil<sup>®</sup> T Clean can only be used for cleaning purposes and may not be used as seam preparation. Sarnafil<sup>®</sup> T Clean reduces the seam quality and should only be used on heavily soiled areas.
- White cloths will effectively absorb dirt and the colour will not stain the membrane.
- Use solvent resistant gloves and eye protection glasses during application.
- Sarnafil<sup>®</sup> T Clean contains high volatile and flammable solvents. Application in closed rooms is allowed only with sufficient room ventilation. Smoking and open fire are not permitted.
