Sika® MultiSeal BT is a self-adhesive sealing tape based on a butyl rubber compound which is protected by a reinforced aluminium metal film.

# **APPLICATION INSTRUCTIONS**

#### SUBSTRATE PREPARATION

The substrate must be stable, clean, dry and free of all contaminants such as dirt, oil, grease, cement laitance, old sealants and poorly bonded paint coatings which could affect adhesion of the adhesive / sealant. The substrate must be of sufficient strength to manage with the stresses induced by the tape during movement. Removal techniques such as wire brushing, grinding, sanding or other suitable mechanical tools can be used. All dust, loose and friable material must be completely removed from all surfaces before application of any activators, primers or tapes. Sika® MultiSeal BT generally has good adhesion without primers/activators to most dry, clean and sound substrates. For optimal results the following procedure must be followed:

#### Non porous substrates

Metals, plastics, coated surfaces, glazed tiles and similar substrates must be cleaned and pre-treated with Sika®Aktivator-205 by using a clean towel. Before sealing allow a flash-off time > 15 min (max. 6 hours).

#### **Porous substrates**

Concrete, aerated concrete and cementitious plasters, mortars, brick, etc. can be pre-heated to increase the adhesion.

#### **APPLICATION METHOD / TOOLS**

Cut the tape to the required length, remove the release film and press the tape firmly onto the substrate with a hard-wheeled roller or suitable tool.

Adhesion performance can be improved by heating Sika® MultiSeal BT tape and / or the substrate during application.

# CLEANING OF TOOLS

Overlaps must be ≥ 50 mm.

Clean all tools and application equipment immediately after use with petroleum or turpentine. Once cured, hardened material can only be removed mechanically.

# **LIMITATIONS**

- Adhesion may increase over time. This effect will be more pronounced on porous substrates and in warm climates
- The upper side of Sika® MultiSeal BT can be overpainted with most conventional paint systems. Do not overpaint the tape with solvent-based paints.
- Do not use on natural stone.
- Due to the bituminous content of the tape, coatings, plastics and natural stones may discolour.
- On porous substrates, water infiltration underneath the tape is possible which may affect adhesion.
- Direct contact with joint sealants and adhesives must be avoided or compatibility must be tested prior to application.
- Do not use Sika® MultiSeal BT for joints under water pressure or for permanent water immersion.
- Not suitable for overhead application when service temperatures are > +25 °C.
- For cleaning skin use Sika® Cleaning Wipes-100 and wash with water and soap.
