APPLICATION INSTRUCTIONS

SUBSTRATE PREPARATION

- Ensure surface is clean, dry or damp (not wet), and free from grease, loose material, and green growth.
- Do not apply to paving laid less than 3 months ago.
- Avoid surfaces treated with silicone or stearatebased sealers.
- Always test on a small area before full application.

APPLICATION

- Stir thoroughly before use.
- Do not apply if rain is expected within 5 hours.
- Apply using a long-pile roller, brush, or low-pressure garden spray.
- Do NOT pour directly onto the surface apply evenly.
- Apply in dry weather above +5 °C.
- Once applied, surface will be dry to touch in approx.
 30 minutes; walk-on in 1 hour.
- Allow 1 hour between coats if applying more than one coat.

Recommended Coats:

Very porous substrates: e.g. concrete flags, some stones:-

2 coats, wait 2 hours between coats. Low porosity substrates: e.g dense block paving:-1 coat is usually sufficient.

CLEANING OF TOOLS

Clean equipment with water and detergent immediately after use.
