Sika® Line & Spot Marking Spray is a spray-applied marking paint designed for clear, temporary to semi-permanent line marking across a wide range of surfaces. Developed for professional use, it delivers high opacity and visibility for surveying, construction, utilities, and sports applications.

The formulation provides durable markings that remain visible for extended periods (typically up to 3 months, depending on conditions), making it suitable for both short-term and medium-term marking requirements.

- Setting out and marking positions on construction and surveying sites
- Identifying underground utilities (electric, water & general marking)
- Excavation and infrastructure works

APPLICATION INSTRUCTIONS

Application Method

- Designed for inverted (upside-down) application
- Shake the can vigorously for at least 2–3 minutes after the mixing ball is heard
- Hold the can inverted and activate the nozzle using finger pressure or an applicator handle
- Maintain consistent distance from surface to ensure even line thickness

After Use / Cleaning

- Clear nozzle immediately after use to prevent blockage
- To clean, turn the can upright and spray briefly (1–2 seconds) away from the user
